14/02/4 To approve the minutes of the HPC meeting of the 10<sup>th</sup> December 2013.

Cllr Thompson raised a query about item 13/32/6, stating that he did not consider that the account from Dor-2-Dor had been approved. The Clerk explained that all of the outstanding accounts had been voted on and approved, but that the Clerk was to investigate why Cllr Thompson had not received a leaflet. The Clerk had determined that other residents in Knowle Park had received leaflets, so the account was paid.

Cllr Harrison proposed, seconded by Cllr Pincombe that the minutes be approved.

Motion carried: 3 for and 2 abstentions.

14/02/5 To receive a report from the Clerk.

The Clerk's report focussed on the Christmas decorations in Handforth centre and the success of the Oakmere Singers performances. Cllr Pincombe thanked Cllr Harrison for the work he had undertaken in connection with the installation of the wall mounted mini Christmas trees.

14/02/6 To approve accounts for payment.

Cllr Martin proposed, seconded by Cllr Thompson that the accounts for payment be approved.

Resolved: unanimously.

14/02/7 To review the operation and future support of the Funside Club (Junior Youth Club).

A verbal report on the Funside Club was received from Mrs M Smith a CEC officer. Cllr Martin suggested that both children and adults from churches in Handforth be invited to join the Funside Club, the Clerk to contact these organisations. Cllr Harrison proposed, seconded by Cllr Martin that this item be brought back to the next meeting of Handforth Parish Council.

Resolved: unanimously.

14/02/8 To agree the precept for the financial year 2014/15

proposed, seconded by Cllr Thompson that the precept for the financial year 2014/15 remain at the current level of £85,000.

Resolved: unanimously.

14/02/9 To consider the future of Handforth Parish Council surgeries.

There was

a proposal from Cllr Thompson, seconded by Cllr Pincombe that Handforth Parish Council surgeries continue in their current format, monthly meetings, with councillors rotating the duty, to be reviewed in April 2014.

Resolved: unanimously.

14/02/10 To consider amending the Handforth Parish Council Standing Orders.

There was a proposal from Cllr Thompson, seconded by Cllr Tolver that the Handforth Parish Council Standing Orders be amended so that at a member's request, ballots for the position of Chair or Vice-Chair of the Council, Committees or Working Groups be determined by secret ballot.

Motion carried: 3 for 2 against.

14/02/11 To consider a written report from Cllr Thompson establishing portfolios for individual councillors.

Cllr Thompson explained the background to his report and the benefits of adopting it. Cllr Pincombe responded that the range of topics was too wide ranging and more in keeping with the duties and responsibilities of a unitary authority. The benefit of gaining expertise was recognised by all councillors, and Cllr Thompson's report was noted without recourse to a vote.
